This report covers the third and final year of this plan and lets you know about some of our achievements and progress in 2019.


There has been a lot going on in the past 12 months and we hope this has helped make your experience of the Children's Hearings System better.


TRESSORE OF OUR ACTIVITY TN 209 VE...


