## **Chair – Cathie Cowan (appointed 2024)**

Cathie comes from a health and care background. She started her career in the 1980s – training as a nurse in Glasgow. Once qualified, she spent time in a variety of both clinical and managerial roles before being appointed to the post of Director of Nursing, Patient Services and Planning within the Kirkcaldy Acute Hospitals NHS Trust in 1995. From this role Cathie then moved to Director of Service Development and Capacity Planning with Fife Health Board.

In 2005, Cathie returned to Glasgow to take up post as the Director of the new south-east Glasgow Community Health and Social Care Partnership. She then moved to Orkney in 2010 as the Chief Executive of NHS Orkney. Alongside this Chief Executive role, Cathie worked as Executive Director for Social Care at Orkney Islands Council for a number of years. She also led the integration of health and social care services before the appointment of Orkney’s joint Chief Officer. In 2018, Cathie took up the post of Chief Executive at NHS Forth Valley. Cathie secured a Health Foundation scholarship and went on to obtain an MSc in Leadership and Quality Improvement at Ashridge. Cathie is a GenerationQ Fellow and a member of the Q community – whose mission is to foster continuous and sustainable improvement in health and care.

Having now retired, Cathie wants to spend her time going forward in an area of work that she is passionate about. Having previously served as a member of the Children’s Panel, her appointment as the SCRA Board Chair enables Cathie to continue her commitment to contribute positively to the lives of children and young people in need of care and protection and to help make Scotland the best place to live, learn, and grow up in.

Much of the work has focused on children, young people and women: managing Youth Agencies and Women onto Work in Edinburgh; working with the European Commission on research and development projects that promoted women and young people's participation in education, enterprise and employment.

8 years ago, after a stint volunteering in rural Senegal with women and children's charities, she returned to Scotland and set-about developing social enterprises that supported women and families. One of those enterprises has won numerous awards for promoting egalitarian values and empowering vulnerable women to be leaders in their lives, careers and communities. She is a former Board Member of a number of charities working on behalf of women, children and other disadvantaged groups.

In March 2020, Hazel was appointed to the Board of the new Economic Development Agency - South of Scotland Enterprise and had a particular remit around the Third Sector, young people and social enterprise. She is also an Associate Consultant for Community Enterprise in Scotland.

Hazel is a former care-experienced young person and someone whose career path has primarily focused on working with disadvantaged groups and communities. That commitment was informed by the first 18 years of her life in care; starting out in youthwork in her late teens - through to setting-up and managing local, regional and national initiatives that focused on equality, inclusion, wellbeing and care for those who are most vulnerable. Board Membership of SCRA is a natural home; an opportunity to work collectively with likeminded others, towards a society that protects, cares for and values our children, our young people and their families.
